If you do not see your occupation listed on the promissory note or on the list shown on the second page of this sheet, we recommend you inquire about this benefit anyway. Please note: If you consolidate your Federal Perkins, you will lose cancellation provision.

It is recommended that you apply for pre-cancellation deferment/cancellation at the beginning of your eligibility to avoid becoming delinquent on your Federal Perkins loan and having your account reported negatively to the credit bureaus. Please make sure to renew pre-cancellation deferment/cancellation at least once per year as long as you qualify. Pre-cancellation deferment allows you to defer loan payments until your deferment end date until you have completed a full year of service (whichever comes first) at which time you will be required to submit proper documentation to LLU for partial loan cancellation.
